## **1) HAZARDOUS MATERIALS RESPONSE TEAM (TYPE 3)**

**1.1) Hazardous Materials Response Team (HAZMAT Team).** Under a Memorandum of Agreement (MOA) with the Maine Emergency Management Agency (MEMA), York County agrees to maintain a Decontamination Strike Team (DST).

Current Mission Situation: Fully mission capable.

**1.1.1) Personnel:** The Team is staffed with reserve employees paid by the hour per event or incident. Most team members are affiliated with a local fire department, others are from private industry. Despite the challenges of the COVID-19 pandemic we have made good progress in the area of recruiting and training.

Current Staffing Situation: As of 12/31/2021, there are 22-people listed on the roster for our HMT. Of that 22, 20 are trained to the technician level. This is an increase of 4 Technicians from this point a year ago, and an increase of 11 in the past 2-years. Two years ago our team had 10-Technicians on the roster, with only 5 medically cleared. All 20 of our Technicians are medically cleared.

Personnel & Human Resources Management: The HAZMAT team currently has seven different job descriptions assigned. This became problematic when we began hiring Fire Instructors (Which will be discussed later in this report). A request has been submitted to consolidate job descriptions and create broader positions covering the various skill sets required.

One Team member, Captain Christopher Allen, was recognized by the Maine American Legion, as their Firefighter of the Year 2022. Captain Allen was recognized for his contributions and leadership during the COVID-19 pandemic response.

Medical and training requirements for 2021 were met.

Organizational Structure: Company Officer positions remain vacant. 2020 Goal near achievement. Company Officer positions remain to be put in place.

Training and Meetings: COVID-19 protective measures have hindered training. Meetings were held via Zoom. We did manage to hold a few meetings and trainings in persons, listed below.

- Held a Technician Level 40-hour course at York County Community College. Funded by State Emergency Response Commission (SERC).
- Eight Step Incident Command Course.
- Technician Skills Refresher Course.
- Meters class with Maine National Guard's 10<sup>th</sup> Civil Support Team.

The standard has been set to ensure all team members are qualified to the appropriate HAZMAT responder level.

**1.1.2) Logistics:** In our MOA with MEMA, MEMA is to provide the necessary equipment to allow the team to fulfill its mission. A standard DST equipment list is provided in the MOA. The County has obtained some additional equipment on its own initiative.

Inventory and Maintenance: Inventory continues to be tracked and maintained in the WASP system. Maintenance records and equipment checks are being completed and documented.

Gas Detection and Photo Ionization (PID) Meters: Our Photo Ionization Detection (PID) meter has been replaced. Our multi-gas detection meters have been replaced and upgraded with an integrated testing and charging unit.

Personal Protective Equipment (PPE): We have been able to obtain with PPE that suitable for multi-mission use. Such PPE must meet NFPA 1951/*Protective Ensembles for Technical Rescue Incidents*. Our Level A entry suits that have failed test or met expiration have been replaced.

Self-Contained Breathing Apparatus (SCBA): MEMA has replaced 5 of our SCBA units. However, no replacement masks or air cylinders were provided. 7 of our 12 SCBA units and 24 air cylinders are over 15-years old. The Maine Bureau of Labor Standards allows SCBA to remain in service for as long as the manufacturer continues to provide maintenance support for the item. The NFPA standard for SCBA indicates that SCBA that is manufactured to standard 3 editions past, is not to be used. NFPA updates its standards every 5 years. Manufacturers tend to follow the NFPA guidance. Which again, after 15-years, our SCBA is 3 editions past. (NFPA 1851/*Standard on Selection, Care, and Maintenance of Open-Circuit Self-Contained Breathing Apparatus (SCBA)*).

Vehicle & Equipment Storage: Completion of the EMA garage project is highly anticipated. Much of our equipment, such as gas and ionization meters, are environmentally sensitive. Storage in extreme cold or heat/humidity has caused maintenance and reliability issues. Our vehicle is at its life cycle end. Replacement of the truck is needed.

Capital Planning: To the best of my knowledge, there does not appear to be capital replacement plan in place. A comprehensive capital replacement plan needs to be implemented and funded for our HAZMAT response team. Without a capital improvement plan, this team is not sustainable.

Current Logistics Situation: Good progress has been made in the past year to replace and upgrade equipment and readiness. A capital improvement plan is needed if we are going to sustain a HAZMAT response capability.

**1.1.3) Operations:** The HMT has met its mission in support of local first responders. Attachment (C) is a listing of incidents and events the team has supported.

COVID-19: Response to COVID-19 protective measures continued to be a focus of the HMT in 2021. The team led efforts in York County for fit testing of first responders, medical personnel, law enforcement and others. Disinfection of buildings and equipment from COVID-19 has been another area of effort.

The team has responded on 44 call outs within the County.

**2) YOUTH FIRE SAFETY PROGRAM**

**2.1) Youth Fire Safety Program (YFSP).**

Mission: The YC YFSP has been able to meet its mission objectives through the COVID-19 pandemic. A return to in-person classes has been accomplished. Yet, COVID-19 fallback procedures and resources remain ready.

**2.1.1) Personnel.**

Staffing: Staffed with two part-time employees. Due to increases in cases, and a recognized need to expand into elderly or other at-risk populations, a third part-time employee is requested.

Training: Our program staff is National Pro Board certified as Fire & Life Safety Educator I. Our staff has completed National Fire Academy instruction in Youth Fire Setter Program Management.

Current Staffing Situation: Current staffing situation is marginal. An additional part-time or reserve employee is needed.

**2.1.2) Case Load and Community Needs.**

- a) This program has seen its number of cases double in the past 2-years.
  - 2021: 25 cases.
  - 2020: 20 cases.
  - 2019: 12 cases.

b) This program focuses on intervention of youth with a propensity to light fires. This program has been very successful at reaching its goals and fulfilling its mission. We do feel that there is a need to expand the program to provide prevention education to the elderly population of York County. Over 21% of the population of York County is over 65 years of age, according to the U.S. Census Bureau.

**3.0) Staffing and Succession Planning.**

Additional staffing is an immediate need in order to meet the current and anticipated case load. Development of a staffing plan is needed to ensure sustainability and growth of the program over time. A staffing plan for this program is necessary for two reasons. 1) It creates more opportunity to expand educational initiatives. 2) It creates stability in our prevention workforce for to ensure our programs are sustainable into the future.

**3) FIRE INSTRUCTOR CADRE.**

**3.1) Background:** This group was first identified in the 2020 Strategic Plan. Authorized in FY2021, COVID-19 delayed implementation of this group. During the Summer 2021 (FY2022) discussions were held with the York County Chiefs' Association (YCCA). A Memorandum of Agreement was signed. In partnership with the YCCA, this group will provide instructor and administrative support to fire and EMS training programs sponsored by YCCA.

**3.2) Personnel.**

Staffing: 13 reserve employees. Goal: 25.

Compensation: Hourly.

Current Staffing Situation: The current staffing situation is adequate. Recruiting continues. As of 12/31/21, we have hired 13 certified Fire Instructors to support this program. An Acting

Chief Fire Instructor has been appointed. Our target is to maintain a cadre of 25 certified Fire Instructors. All employees are Reserve Employees of the County.

**3.3) Mission and Capabilities.**

3.3.1) Mission: The York County Fire Instructor Cadre is to provide qualified instructors to deliver training and professional development programs to emergency service organizations within York County.

3.3.2) Capabilities: a) This organization will maintain capabilities to instruct training programs in accordance with National Fire Protection Standards, rules and guidelines set forth by the Maine Fire Service Institute, Maine State Fire Marshal, Maine Emergency Medical Services Bureau, Maine Bureau of Labor Standards, Maine Forest Service and as other State and Federal laws, rules or directives require. Needs of local communities will be considered in determining needed training capabilities.

b) As a point of procedure, several of the HAZMAT Technicians already in County employment, are certified fire instructors. Many of these Technicians expressed desire to additionally serve as Instructors. In order to utilize these individuals as Instructors, they were required to go through the hiring process again from the beginning. This has caused much re-work and has proved to be an inefficient use of resources. A proposal has been submitted to make changes to various job descriptions to provide for more efficient employment of these highly training individuals.

**3.4) Programs:** For 2022, the Fire Instructor Cadre is providing instructors to the York County Firefighter I and II program.

**3.5) Equipment/Curricula:** A needs assessment will be conducted to determine actual needs. Items such as firefighter PPE, are being borrowed from the employee's primary employer. The YCCA and MFSI is providing the necessary curriculum for the 2022 Firefighter I and II program.

**4) OFFICE of FIRE and EMERGENCY MEDICAL SERVICES ASSISTANCE.**

**4.1) Mission:** A coordinated, cost-effective organization committed to enhancing the quality of life through a collaborative, regional approach to delivery of fire protection, technical rescue and emergency medical services that aid, protect, and support our residents and visitors.

**4.2) Personnel.**

**4.2.1) Chief Fire Administrator.**

Staffing: One employee.

Compensation: Salaried.

Current Staffing Situation: The current staffing situation is adequate. A professional development program is needed. Review and update of the job description should be conducted.

#### **4.3) Outreach, Liaison, Marketing.**

COVID-19 Pandemic Response: Continue to support pandemic response efforts.

Vaccination Clinic: From February through June, the Fire Administrator was assigned as the Manager of the Mass Vaccination Clinic established by York County EMA in cooperation with Maine Health.

Town of Limerick: Assisted Town officials with search and interview process for hiring a municipal fire chief.

Massabesic Experimental Forest: At the request of the US Forest Service, and in cooperation with the local fire departments that border the forest, a grant of \$150,000.00 has been secured to support a Community Wildland Protection Plan for the Massabesic Forest. The grant will be administered by the Forest Steward's Guild. This grant will provide funding for training, equipment, and development of a response plans to a fire emergency in the forest. This grant will not only benefit Towns that boarder the forest but will help their mutual aid as well.

Fire/EMS Communications Working Group: Member of a 7-person working group to update and standardize the procedures used by the Sanford Regional Communications Center.

York County Community College: I am happy to report that we have developed a solid partnership with York County Community College. The future looks bright for the delivery of EMS courses here in York County. The need for such a partnership comes from the need to increase capacity for training EMTs and Paramedics to meet workforce demands.

*EMS Programs*: Working in cooperation with the Maine Community College System, we have brought Emergency Medical Training programs to the York County Community College campus in Wells. Funded with Workforce Development funds from the Maine Quality Center, we have been able to offer a Basic EMT course for free. The long-term goal is to formalize this partnership and bring certified EMS training center in York County.

*EMS Employer Board*: In partnership with YCCC, we have developed a York County EMS Employer Board. The purpose of this board is to gain employer input on training and education needs of EMS agencies in York County.

*Fire/Special Operations Programs*: Together with YCCC we have hosted a HAZMAT Technician Initial Course (40-hours). And have scheduled a 40-hour Fire Inspector I class for January 2022.

Firefighter Registry: Much effort was put into creating a concept of a firefighter hiring registry. The idea is to conduct a unified hiring process to develop a list of candidates ready for hire by local fire departments. The Human Resources necessary to operate such a program are not available at this time.

All Hazards Training Facility: I want to thank the County Commissioners for supporting the creation of the York County Strategic Planning and Readiness Center. Development of such a facility will have a significant impact on the preparedness of our first responders. Senator Susan Collins through Congressional Discretionary Spending has ear-marked \$850,000.00 for this facility.

Committee: Serves on the Strategic Planning and Readiness Center Committee.

#### **4.4) Operations.**

The County Fire Administrator responded on 13 incidents around the county. Providing incident management support and assistance to local fire chiefs/incident commanders.

#### **4.5) Budget.**

Budget: No budget currently exists. This office is funded as part of the Emergency Management Agency. A budget has been provided to the County Manager. That budget recommends moving this office into its own line item separate from EMA.

Grants: Grant opportunities are being researched. Because this office isn't recognized as a fire department, we are not eligible for FEMA's Assistance to Firefighter Grants. Applications submitted to Firehouse Subs Foundation; Steven & Tabitha King Foundation both were denied.

Group Purchasing: Secured a group purchasing arrangement with Emergency Services Marketing Group, LLC. ESMG provides a software platform call *I Am Responding*. This is a first responder notification app and website. All fire and/or EMS agencies in York County participate in this program. The group purchase saves each community roughly \$200 off their annual subscription.

An arrangement with the National Fire Protection Agency has been made to provide electronic access to NFPA codes and standards. The service is called "NFPA Link" 12 departments in the County participate in this program.

Assembling information regarding options for group purchase of records management software. Held three video conferences with area departments and vendors.

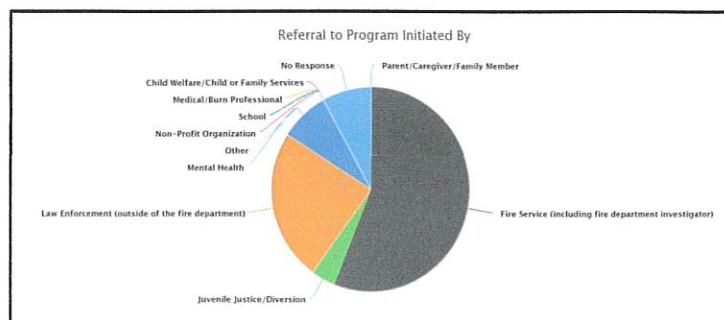

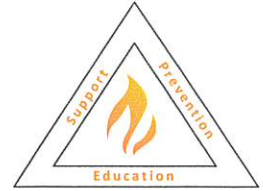
### *Program Achievements*

- A National Fire Academy Youth Firesetter Prevention and Intervention program was delivered in a hybrid model during the month of March. This hybrid model allowed for a diverse group of attendees to include four additional counties that have not been represented in the youth firesetter intervention circles.
- Program staff participated in ongoing programmatic support from Janice Teasenfitz, LCSW for continued program development and guidance for complex cases.
- Program staff have begun utilizing a hybrid model for youth firesetter intervention. While challenging, staff are navigating the use of technology to improve support and education to families.
- With challenges related to the ongoing pandemic and transportation issues, program staff have transitioned fire safety education to an online platform based on the child and family needs. This has been extremely beneficial as it has allowed program staff to access youth and families who normally would struggle with class attendance based on varying factors.
- The program staff developed a parent fire safety education program, following several cases that limited initial education to children based on behavioral health resources. The program proved extremely valuable and sought to address primary concerns related to firesetting those being access to matches/lighters and supervision.
- Program staff formed renewed relationships with fire service professionals from Kittery and Eliot Fire Departments. This is a new area of expansion for us in recent years noting challenges of time and distance related to providing education.

*Outreach & Collaborative Efforts*

- Program staff participated in the initial collaborative meeting for Oxford County on March 17<sup>th</sup>, 2021. The Oxford County youth fire safety collaborative have been creating a framework to address youth firesetting within their communities. Program staff have supported this collaborative effort by providing guidance and documentation.
- Program staff met with the Pine Tree Burn Foundation to discuss the Fire and Life Safety Educator I program. Program staff will be collaborating with Pine Tree Burn Foundation in the coming months to support both a full course and abbreviated Fire and Life Safety Educator I model.
- Program staff met with Long Creek Youth Development Center to discuss collaboration on a fire safety program for the facility. Program staff along with Cumberland County staff conducted a fire safety jeopardy training, which was well received.
- Program staff have been working with a national group that is developing youth firesetter intervention curriculum. This partnership should yield benefits for the program as well as contributions to a national standard.
- Program staff met with Scarborough fire department and police department's behavioral health clinician to discuss youth fire safety. This relationship will prove to be beneficial in the coming years to support both York County and Cumberland County programs.
- Program staff were elected to serve as members of the Pinetree Burn Foundation. Molly Cunningham was elected to serve as assistant secretary, while Matthew Leach was selected to serve as vice-president. The program staff have worked closely with a Pinetree Burn Foundation, as this has connected staff to individuals around the state who are committed to fire and life safety education.
- Program staff have begun reestablishing the relationship with the American Red Cross smoke alarm program coordinator. The program was placed on hold based on the ongoing pandemic but has recently begun the process of reestablishing the program with community stakeholders.
- The program staff continue to work closely with Pinetree Burn Foundation in developing a support framework for youth fire safety programs statewide. This has primarily involved taking current program documentation and creating generic documentation that could be utilized by future collaboratives.

### *Needs Assessment: Personnel/Staff, Training, Material, Financial*

- Program staff are often in need of sites throughout York County to hold fire safety education sessions. There has been some discussion on improving online resources to increase the effectiveness of online delivery of youth fire safety programs.
- There is need to develop a succession plan as the organization continues to grow and evolve to meet the diverse needs of the community. This consideration focuses on adding individuals to the program that could be trained and mentored in alignment with proper succession planning.

### *Program Goals for 2022*

- The program staff plan to deliver a youth firesetter intervention and prevention program in Summer / Fall 2022.
- The program staff are working with Pinetree Burn Foundation to achieve instructor training in the NFPA “Remembering When Program”. This is an ongoing effort as staff are required to receive train-the-trainer prior to the presentation of a community program. Remembering When is centered around 16 key safety messages – eight fire prevention and eight fall prevention (NFPA, 2022). Program staff can decide how to best approach the local senior population: through group presentations, during home visits, and/or as part of a smoke alarm installation and fall intervention program.
- The program staff are partnering with Pinetree burn foundation to support both the fire and life safety educator I program and youth fire safety throughout the State of Maine. The program staff hope to continue to advance standardization of education in partnership with the Pinetree Burn Foundation. This is a new initiative for both organizations, which has created new relationships and partnerships with a common goal of advancing fire safety prevention and education.
- The program staff are currently working with the State of Maine Fire Marshal’s Office to coordinate a quarterly meeting of state youth fire safety collaboratives. The York County program has a well-established relationship with the State of Maine Fire Marshal’s Office and will partner to support other programs throughout the state through collaboration and ongoing training.
- In alignment with the goal of succession planning, consideration is focused on adding additional staffing to the program. This goal is twofold as it creates more opportunity to expand educational initiatives, while creating sustainability for future efforts.





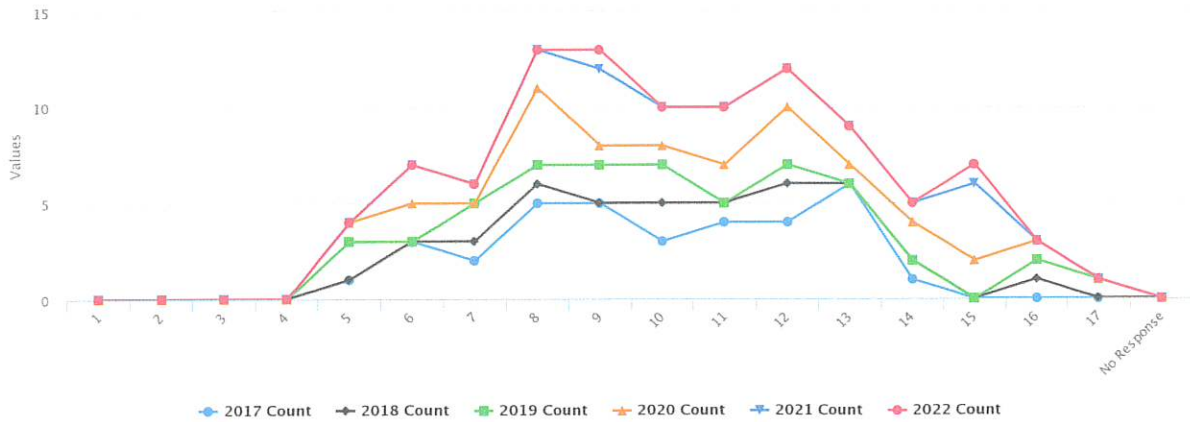

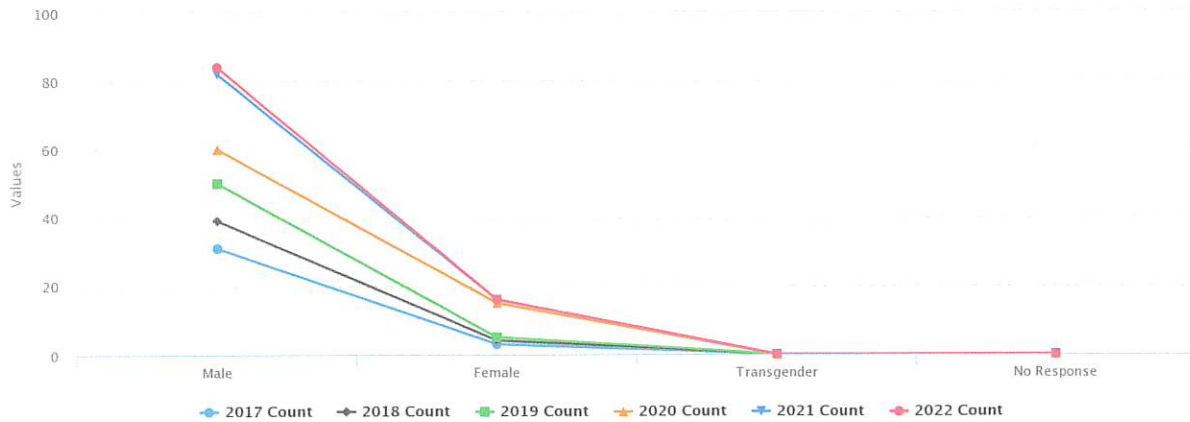

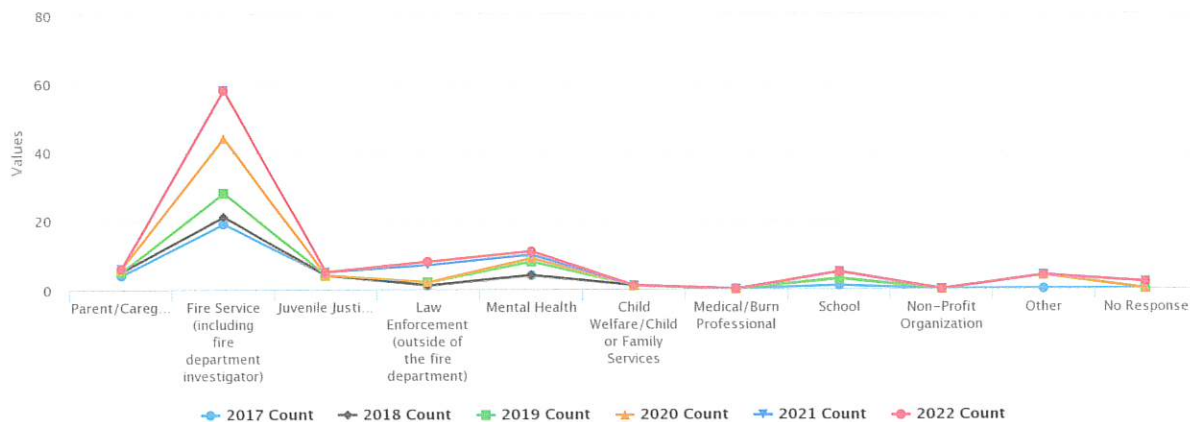
Age at the Time of Incident

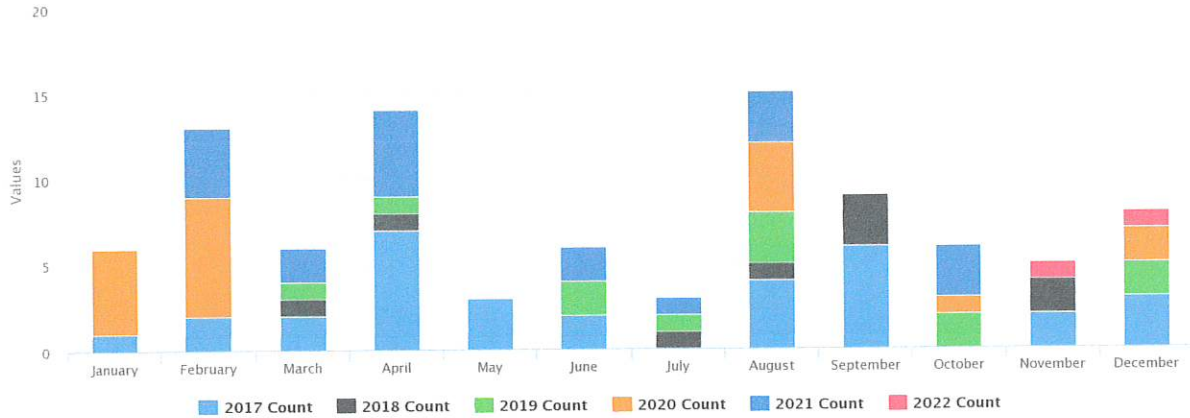

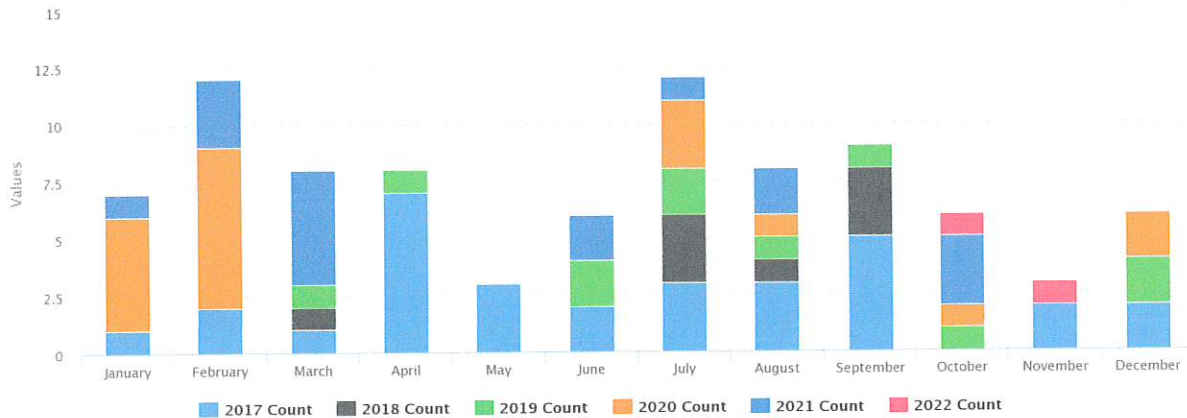

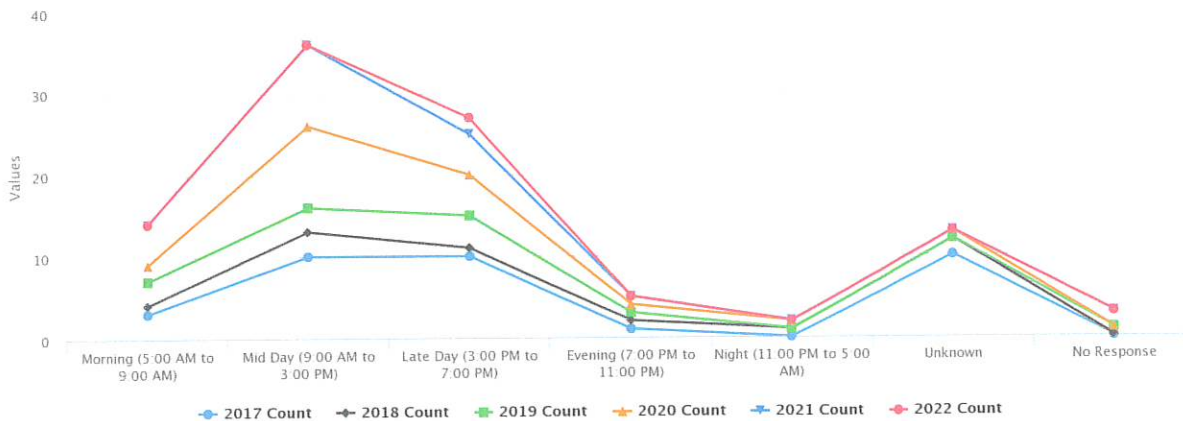
Referral Date by Month

Incident Time of Day



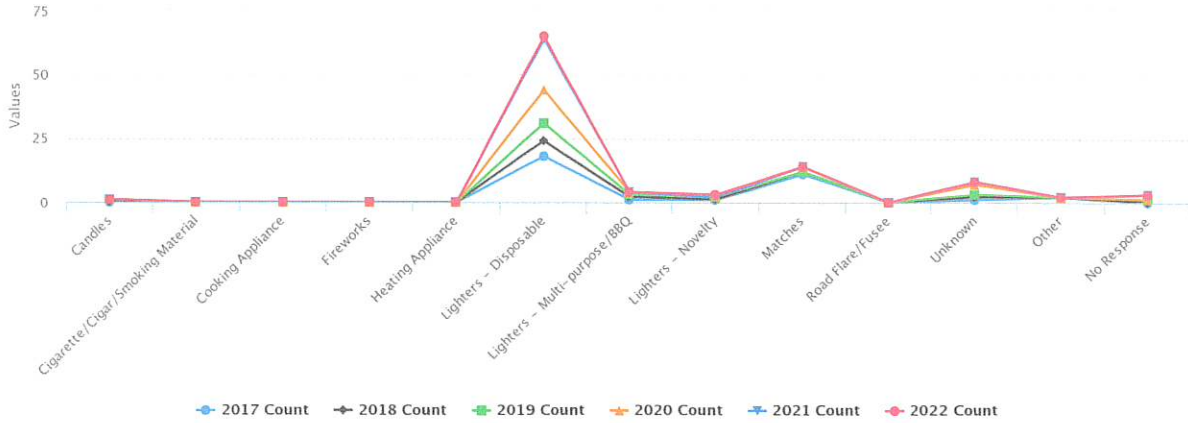

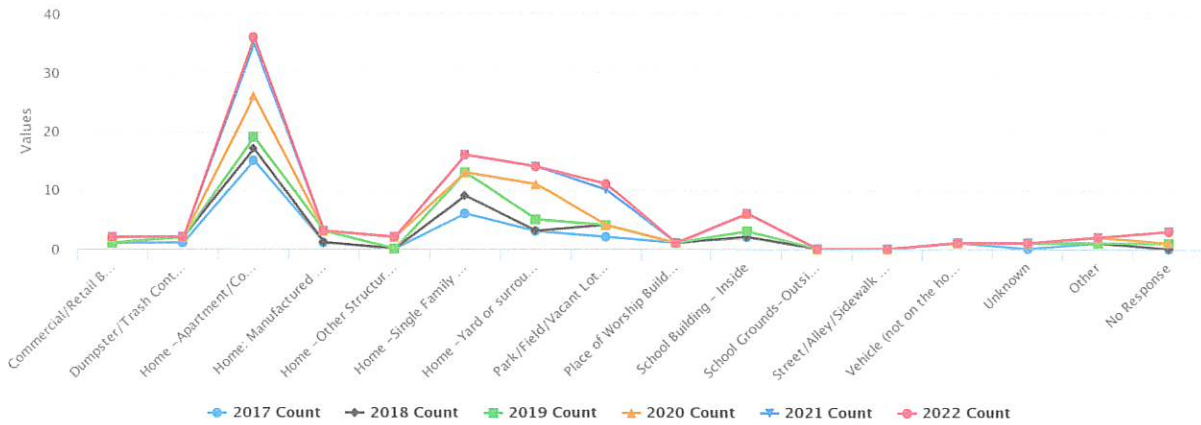

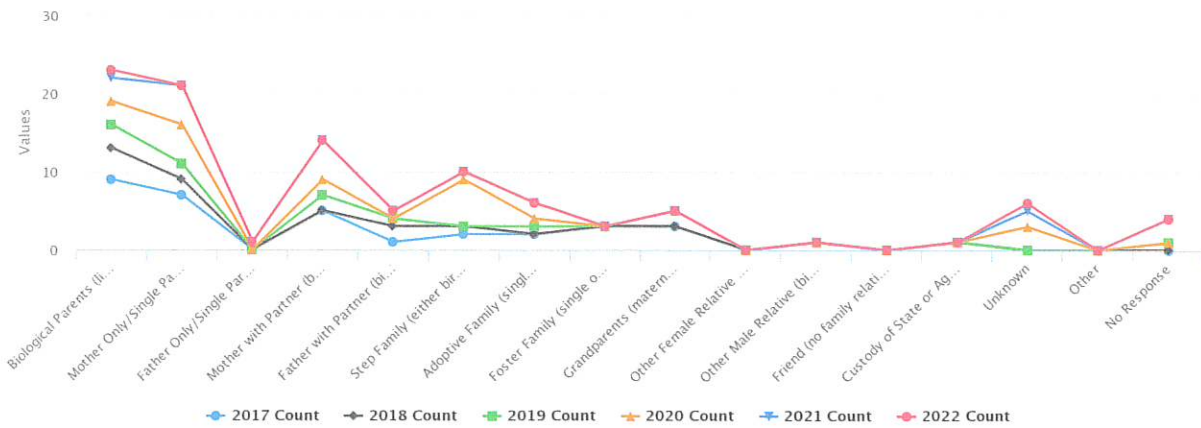
Ignition Source
